(3) by, to or between any employee/staff member of the Office of Lt. Governor and any employee/staff member of any other agency of the state of Mississippi, members of the Mississippi Legislature and state-supported community colleges and universities.

(4) by, to or between any employee/staff member of the Office of Lt. Governor and any private citizen.

I understand that this specific information is public record and can be compiled from records kept by the Office of Lieutenant Governor; that you will notify me in advance of any costs associated with producing the above-described information; that you will state in writing the reasons for denial of any portion of this request; that this request will be fulfilled within 14 working days from the date of receipt of this letter; and that failure to respond to this request as prescribed by law can result in injunctive relief in a Hinds County Chancery Court.
