NARRATIVE

On September 8, 2017, I, Officer Dyron Talbert, spoke with a Mrs. Melanie Hagood concerning her son's black iPhone 5s that had been stolen while he was at the Depot Bowling Alley. Her son stated that he was at the entrance of the bowling alley when a male subject came up and asked him if he knew him, her son stated that he did not know who he was, the unidentified male subject then pulled a gun on her son and said "give me all of your money" her son stated "I only have a dollar and a phone", her son then handed the unidentified male subject his phone and the dollar, her son also told him that his phone was dead, and the unidentified subject told him to give him the pass code, her son gave him the pass code and then the subject ran off back towards the bowling alley.
