WHEREAS, due to the delays in concluding the project requiring that the Construction Period Savings be adjusted and that the Guarantee Period Savings for the small meters be revised; and

WHEREAS, the parties agree that all additional work on the utility billing system will be completed on September 30, 2018; and

WHEREAS, the Department of Public Works recommends that the governing authorities of the City accept this Amendment.

IT IS, THEREFORE, ORDERED that Amendment No. 4 to the Performance Contracting Agreement between the City of Jackson, Mississippi and Siemens Industry, Inc., Building Technologies Division is accepted.

IT IS FURTHER ORDERED that the Mayor is authorized to execute Amendment No. 4 to the Performance Contracting Agreement between the City of Jackson, Mississippi and Siemens Industry, Inc., Building Technologies Division.

## Background:

The City of Jackson and Siemens entered into a Performance Contracting Agreement to provide new AMI meters, metering infrastructure, a new utility billing system, and repairs to the water and sewer systems. The project has been ongoing for over four years.

The installation of meters in the City of Byram service area is being completed, which will conclude the installation of meters under the Agreement. It is now possible to calculate the number of meters that will actually be installed versus the number of meters provided in the Agreement. The net difference is 4,800 meter that have not been installed from the original number of meters to be supplied under the Agreement. The Agreement also contained a contingency amount. Finally, the Agreement included the installation of new filter media in one of the sedimentation basins at the J.H. Fewell Water Treatment Plant. The total scheduled value of this work is \$1,122,609.38.

The City of Jackson continues to experience serious issues with the new utility billing system. The issues continue to prevent the City from billing all customers each month. To resolve these issues, I have negotiated with Siemens to provide the necessary services from their subcontractors through September 30, 2018 to resolve the issues with the utility billing system. The value of these services will be \$1,122,609.38, which is a net zero change in the present contract amount.
